- No edible products may be sold unless agreed to beforehand. Health Department Regulations apply.
- Set up time will from 8 a.m. till 11 a.m. All displays must be ready by 12 noon.
- Any organization soliciting donations must do so in an unobtrusive and voluntary basis.
- Vendors and non-profit organizations are required to stay within the area defined as their display space as stated on their application.
- Vendors and non-profit organizations may not approach guests outside their defined area, but must wait until guests approach them.
- No flyers or other print materials may be left on visitors' cars.
- Any guest complaints regarding vendors and non-profit organizations will be responded to at the time of the complaint and appropriate action will be taken. This may include removal from premises or any required legal action. This vendor or non-profit organization may be prohibited from participating at any future Our Ramara FunFest.
- Vendors and non-profit organizations must park in the areas designated by FunFest, and follow all procedures set out in parking policy.
